Effective July 2025, the Organization entered into an affiliation agreement with The Margin of Change Foundation Inc. ("Margin") and became a subsidiary organization of The Margin of Change Foundation Inc. The agreement preserves Ashes to Glory Foundation's separate legal existence and provides that Ashes to Glory Foundation will continue to conduct its charitable programs through its own corporate structure, officers, management, and Board of Directors. Under the affiliation agreement, Margin has governance rights, including the authority to appoint members of Ashes to Glory Foundation's Board of Directors following the transaction. The agreement also contains provisions intended to preserve certain governance protections for Ashes to Glory Foundation, including the authority of its independent directors to terminate the affiliation upon notice and restrictions on Margin's ability to alter those termination rights. Accordingly, while Ashes to Glory Foundation maintains separate operations and corporate records, it is affiliated with and subject to certain governance rights of Margin under the affiliation agreement.

In connection with the affiliation, the Organization amended and restated its governing documents to establish a sole-member governance structure. The Margin of Change Foundation Inc. became the Organization's sole member and was granted certain governance rights, including the authority to appoint members of the governing body and approve certain significant organizational actions.

The annual process for determining compensation is as follows: The Nonprofit shall annually evaluate the Executive Director on his performance and ask for his input on matters of performance and compensation.

Board Approval: The Board will obtain research and information to make a recommendation for the compensation of the Executive Director based on a review of comparable data. For example, the Board will secure data that documents compensation levels and benefits for similarly qualified individuals in comparable positions at similar organizations. This data may include the following:

1. Salary and benefit compensation studies by independent sources;
2. Written job offers of positions at similar organizations;
3. Documented telephone call about similar positions at both nonprofit and for-profit organizations; and
4. Information obtained from the IRS Form 990 filings of similar organizations.

Compensation Committee of Independent Board Members: A Board committee consisting of three Board members who are independent of the Executive Director will examine and determine the proper compensation for the Executive Director, at least annually. The compensation committee will then present their decision to the full Board for final approval.

Other Compensation Policy: Ashes to Glory Foundation is committed to establishing compensation that will attract and retain high-performing employees at all levels. The Executive Director reviews all salary levels before the start of the organization's fiscal year and adjusts the various levels based on market, performance, and changes in responsibility.
